






Fig. 4. Propagation delay input (nA) to output (nY)





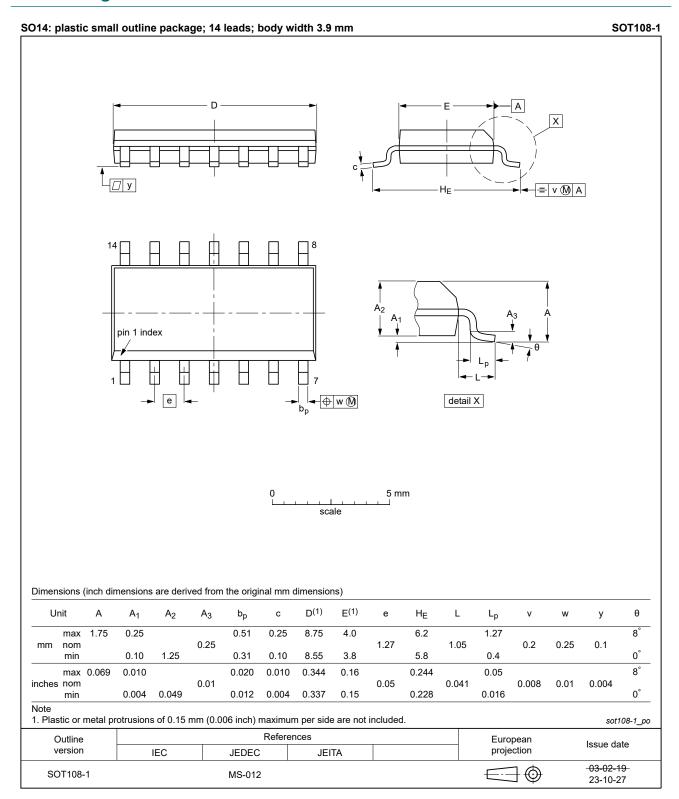


Fig. 7. Package outline SOT108-1 (SO14)




Fig. 8. Package outline SOT402-1 (TSSOP14)
