




Figure 1. Typical Pulsed Current Gain vs.
Collector Current




Figure 3. Base-Emitter Saturation Voltage vs.
Collector Current




Figure 5. Collector Cut-Off Current vs.
Ambient Temperature




Figure 2. Collector-Emitter Saturation Voltage vs.
Collector Current




Figure 4. Base-Emitter On Voltage vs. Collector Current




Figure 6. Collector-Base Capacitance vs. Collector-Base Voltage




Figure 7. Gain Bandwidth Product vs.
Collector Current




Figure 8. Power Dissipation vs. Ambient Temperature




Figure 9. MOLDED PACKAGE, SOT-223, 4 LEAD (ACTIVE)
